Confidentiality and Release Agreement

Begg'n To Stay, LLC, d/b/a/ Dog Days, ("Dog Days"), its owners, its employees, and its independent contractors are committed to providing a safe, healthy environment for all of its customers and their pets. Pet ownership, daycare, grooming, boarding and training, however, present certain risks. Such risks include, but are not limited to dog bites, dog fights, transmission of diseases, and other incidents that may occur on the premises of Dog Days or while pets are being exercised off the premises.

For the sole consideration of Dog Days allowing the undersigned ("Releasor") to receive daycare, grooming, boarding, training and/or other services from Dog Days, Releasor, on his/her behalf and on behalf of his/her heirs, executors, administrators, assigns and all co-owners of Releasor's pet(s), hereby now and forever, fully and finally, releases, acquits and discharges Dog Days, its owners, employees, agents and assigns from any and all claims, demands, rights and causes of action of whatsoever kind and nature, arising from bodily and personal injuries, damage to property, and the consequences thereof, no matter the cause, resulting from or in any manner related to the provision of daycare, grooming, boarding, training or any other services offered by Dog Days. Releasor understands and acknowledges the significance and consequences of such specific intention to release such claims and hereby assumes full responsibility for any damages or losses incurred by releasor by reason of the aforesaid release.

Releasor hereby authorizes Dog Days to obtain medical and vaccination records for Releasor's pet(s), to contact Releasor's veterinarian directly for purposes of obtaining such records, and to contact said veterinarian directly should the need arise.

The terms and conditions of this Agreement and services provided under this Agreement shall be kept strictly confidential by myself and will not be disclosed to any third party, except as may be required by law. I understand that information within this agreement and methods of caring for my pet(s) are proprietary and that disclosure of such information would harm the business of Dog Days. I further understand the necessity, in the event of disclosure, for Dog Days to obtain a court ordered injunction necessary to force compliance with this provision.

AUTHORIZATION, ACKNOWLEDGEMENTS AND WAIVER

Credit Card Charges

I authorize Begg'n To Stay, LLC ("Dog Days") to maintain my credit card number on file and charge purchases made and/or services rendered against the card at the prices in effect at the time of the transaction. I authorize Dog Days to charge my credit card at their option at either the time of my making a reservation or at commencement of my dog's usage of services. This charge will be in the approximate amount of the cost of services rendered. Charges will be in an amount sufficient to pay my bill in full, and **all charges, are final when made.** In the event of a charge, Dog Days may decline to provide services if my credit card is declined for any reason. In the event a charge is declined, Dog Days may assess a declination charge not to exceed the greater of \$10 or the maximum otherwise permissible for late charge assessments in addition to any charges assessed by the paying institution against Dog Days with respect to a dishonored transaction. Alternatively, if any of the foregoing charges to my card are declined, Dog Days is authorized to charge my spouse's or designated other's card if it is on file. The fact that it is on file constitutes consent by the card holder to do so. In the event that my (or my spouse's or designated other's) credit card cannot process payment due to a limitation placed on individual transactions, Dog Days may divide the total charge into incremental portions in order to process the charge. **I understand that all pre-paid package charges on day camp, as well as deposits on boarding, are non-refundable and non-transferable between Dog Days locations.**

Dog Behavior and Health

I understand that Dog Days reserves the right to refuse services or use of its facilities for dogs who, in its sole determination, are unhealthy, act aggressively, are undisciplined, evidence inappropriate behavior or who may otherwise be a danger to themselves or other animals or users. **To use the facilities my dog must be spayed or neutered if it is older than 8 months of age.** Distemper, Parvo, Rabies and Bordetella vaccinations must remain current. If requested to do so, I will provide Dog Days with an up-to-date health certificate verifying compliance with these requirements. Dog Days reserves the right to suspend usage if I do not provide required verification, and in such event I am not entitled to any refund or credit. I acknowledge that I undertake responsibility for, and will not hold Dog Days liable for, any illness or ailment which my dog may incur while in the presence of other dogs at the facility or otherwise.

Injuries

I acknowledge that dogs are encouraged to socialize and exercise at Dog Days and that injury to my dog can reasonably be foreseen to result from playing and roughhousing while in the care of Dog Days. I agree to assume the risks and hazards that might be expected to arise from such use and the presence of my dog's interaction with other animals. I also agree that Dog Days shall not be responsible, monetarily or otherwise, for injuries to my dog which may arise in the course of play or which may be caused by the presence of actions of other dogs. I shall hold Dog Days and its employees harmless from, make no claim against, and indemnify Dog Days and its employees against any costs, damages, claims or expenses (including vet fees) that may result from an injury or illness to my dog, or to another dog, if caused by my dog. **I understand that my agreeing to the foregoing and specifically, my agreement to not hold Dog Days responsible for the payment of veterinarian bills is of the essence of this agreement and that Dog Days would not agree to care for my dog without this inducement to do so.**

Veterinary Care

If, in my absence, my dog should be injured, become ill, or is otherwise deemed by Dog Days to require immediate veterinary attention, Dog Days is authorized to consult with and utilize the services of my veterinarian for treatment and guidance. If my veterinarian is unavailable, Dog Days is authorized to utilize the services of any other reputable veterinarian. **I understand that I am responsible for any charges with respect to any such veterinary care.** I also authorize Dog Days to have full access to my dog's veterinarian records and past medical history.

Additional Care

Dog Days is not responsible for the loss of or damage to any personal property which I may leave at the facility (including: beds, harnesses, leashes, toys, etc.). I understand that my dog must have a secure collar or harness to wear during its day at Dog Days, and for safety purposes, my dog must also have an identification tag attached to its collar or harness.

In the event that I am boarding my dog, Dog Days will feed my dog with food that I leave at the facility. I will ensure that the food is properly divided into daily portions, and that it is labeled with my dog's name. If I wish Dog Days to provide food, I understand that Dog Days will purchase food out of its retail store for an additional charge at the then retail price.
